FA 1 – Discussion of 2021 Budget Schedule and Need for Line of Credit and Other Cashflow Issues

David DiLena, Finance Manager, walked through the preliminary budget for Fiscal Year 2021 (FY21). DiLena discussed the need for a line of credit for the Capital Budget, totaling an amount of \$675,000. This amount will be utilized to pay contracted vendors until the payments are eligible for reimbursement through grant funds.

DiLena is anticipating ending the Fiscal Year 2020 (FY20) with a surplus of about \$8,000 for the Operating Budget, which may be utilized in the Operating Budget for FY21. However, to allow the Authority to bring this project to completion, an additional \$50,000 from both Washington and Holmes County will be necessary. Furthermore, an additional \$25,000 will be needed from both Washington and Holmes County to carry this project to completion.

The tentative budget meeting will be held in August 2020, with a final budget meeting scheduled to be held in September 2020.
